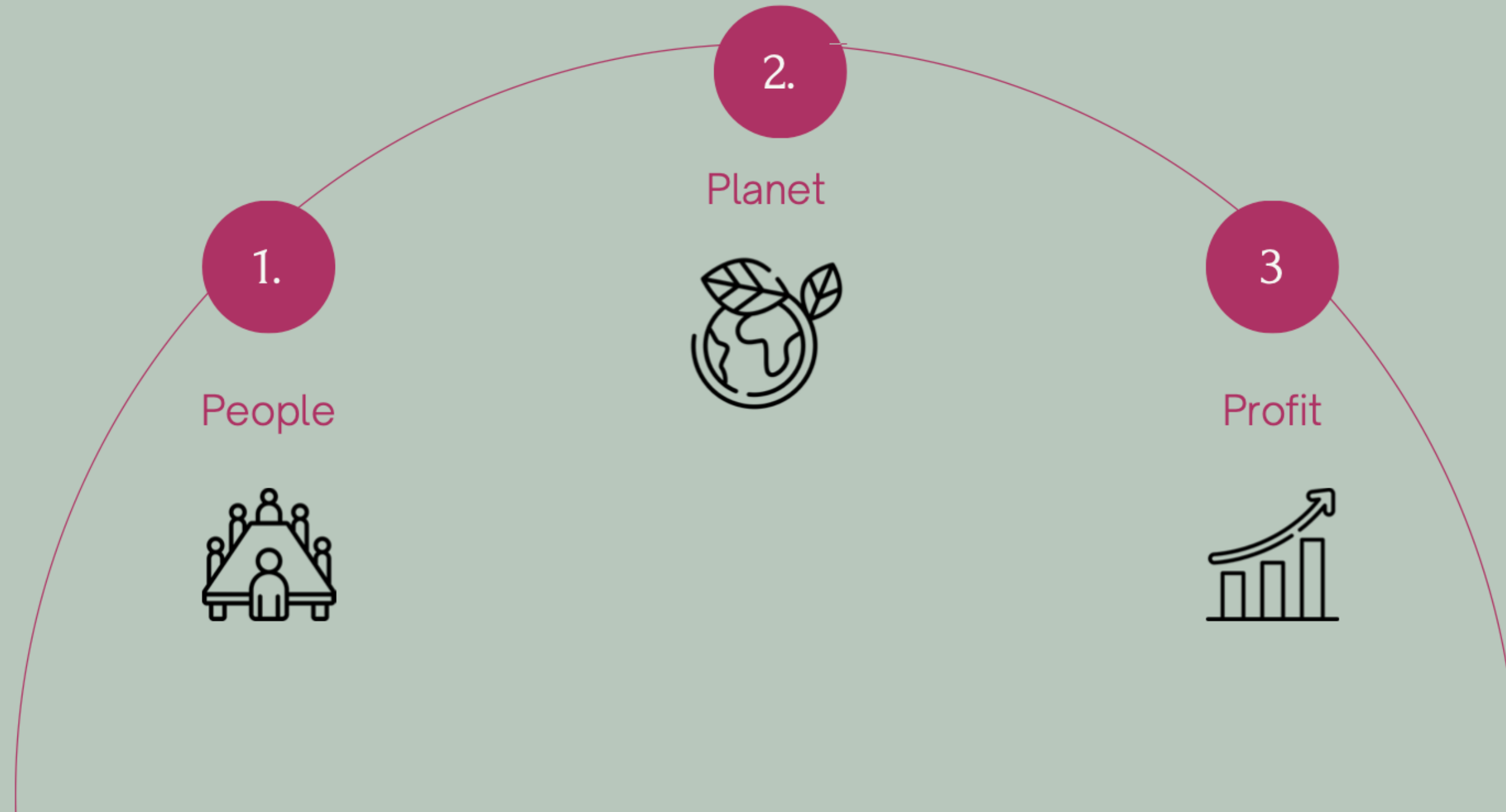


OUR MISSION
